SUMMARY

Offer Price and net proceeds from the Share Offer

- The Offer Price is HK\$0.70 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.70 per Offer Share, the net proceeds from the Share Offer to be received by the Company, before exercise of the Over-allotment Option, and after deducting the underwriting commissions and other estimated expenses payable by the Company in relation to the Share Offer, is estimated to be approximately HK\$79.3 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net proceeds from the Share Offer” below.

Applications under the Public Offer

- A total of 5,451 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 1,266,210,000 Public Offer Shares, equivalent to approximately 68.44 times of the total number of 18,500,000 Public Offer Shares initially available for subscription under the Public Offer. Due to the significant over-subscription in the Public Offer, a total of 55,500,000 Placing Shares have been reallocated from the Placing to the Public Offer. The final number of Offer Shares under the Public Offer is 74,000,000 Offer Shares, representing 40% of the total number of Offer Shares initially available under the Share Offer (assuming the Over-allotment Option is not exercised).

The Placing

- The Offer Shares offered under the Placing have been slightly over-subscribed which is equivalent to approximately 1.34 times of the total number of 166,500,000 Placing Shares. The final number of Offer Shares allocated to 101 places under the Placing comprises 111,000,000 Offer Shares, representing 60% of the total number of Offer Shares initially available under the Share Offer (assuming the Over-allotment option is not exercised) and an over-allocation of 27,750,000 Shares. A total of 80 places have been allotted five board lots Placing Shares or less, representing approximately 79.2% of total number of places under the Placing. A total of 425,000 Placing Shares have been allotted to these 80 places, representing approximately 0.3% of 138,750,000 Shares (comprising 111,000,000 Offer Shares under the Placing tranche and an over-allocation of 27,750,000 Shares).
