The Board is pleased to announce that Mr. Lo Wing Sang (“**Mr. Lo**”) will be appointed as the Company Secretary and Authorized Representative in place of Ms. Lee with effect from 1 October 2019.

Mr. Lo, aged 53, is the financial controller of the Company. He has more than 30 years of experience in corporate finance, management and accounting. He previously held positions chief executive officer, chief financial officer, chief operation officer and company secretary. He has been appointed as an executive director of Wan Leader International Limited, a company listed on the GEM of the Stock Exchange (stock code: 8482) since 1 November 2017. He holds a Bachelor of Arts in accountancy from the City Polytechnic of Hong Kong (presently known as City University of Hong Kong), and is a practicing member of the Hong Kong Institute of Certified Public Accountants, a fellow member of both the Institute of Chartered Accountants in England and Wales and The Association of Chartered Certified Accountants, and an associate member of the Hong Kong Institute of Chartered Secretaries.

The Board would like to take this opportunity to express its gratitude to Ms. Lee for her contribution to the Company during her tenure of service and also express its warm welcome to Mr. Lo on his new appointment.
